Report on Financial Statements:

We have audited the accompanying financial statements RAHMAN COLLEGE OF EDUCATION, which comprise the Balance Sheet as at March 31st, 2023, and the Income and expenditure account for the year then ended, and a summary of significant accounting policies and other explanatory information, which we have signed under reference to this report.

Management's Responsibility for the Financial Statements:
